# **Regulatory update**

### Recently Enacted Government Decrees and Legislation:

### **Re-Denomination of Foreign Currency Agreements in Turkish Lira**

On 13 September 2018, a decree has been issued on amendment on the Decree No. 32 on the Protection of the Value of the Turkish Currency which provides that contract prices or other payment obligations specified in certain types of agreements executed between real or legal entities residing in Turkey must be denominated in Turkish Lira. Therefore, as of 13 September 2018, it will no longer be possible for prices in such agreements to be determined in foreign currency or indexed to foreign currency. The objective of the decree is to avoid further inflation.

The agreements falling under this restriction are as follows:

- Sale and purchase of real estate
- Sale and purchase of movable properties
- Leasing of real estate and movable properties, including financial leasing and leasing of vehicles (cars and other vehicles)
- Employment agreements, service agreements and independent constructor agreements (work contracts).

While all new agreements to be executed following the enforcement date of the decree, i.e. 13 September 2018, will need to be determined in Turkish Lira, a 30 day-period has been granted to bring existing agreements in compliance with the new rules. Last Friday, 16 November, the decree was amended to state that lease and purchase agreements that were nominated in foreign currency can stay as foreign currency.

### Temporary Obligations on Export Proceeds in Turkey

On 4 September 2018, The Ministry of Treasury and Finance has enacted a new Communique on the Protection of the Value of Turkish Currency concerning the activities of exporters in Turkey. Under the new regulation, the proceeds arising from the export activities facilitated by the residents in Turkey must be either transferred directly and immediately to the bank that mediates the export transaction or directly brought into country. The objective hereof is to avoid funds from beings transferred abroad and not returning to Turkey.

The duration for export proceeds to be brought into country should not exceed 180 days after actual export date. It is also compulsory to convert at least 80% of the aforementioned export proceeds into Turkish Lira by transferring respected proceeds to a Turkish bank. The communique will be valid as of 4 September 2018 to the following 6 months and constitutes a temporary regulation. The analysis hereof on our business is continuing.

# Amendment to Regulation on Commercial Advertisements and Unfair Commercial Practices

# A new article addressing the current currency fluctuations on consumer sales prices is introduced to the "Misleading Commercial Practices" section of the Regulation on Commercial Advertisement and Unfair Commercial Practices' Annex titled "Examples of Unfair Practices".

The article, added to "Misleading Commercial Practices" section of the Annex reads:

"To increase the sale price of a good or service offered to the consumer without a valid reason and indicating that the sale price increase is a result of changes such as input cost and the exchange rate, even though the sale price is unaffected by these changes [is a misleading commercial practice]." The objective of this amendment is to avoid that legal entities abuse the current situation of the FX and impose a price increase, whereas there may not be impacted of the FX rate. Hence generating a profit for themselves at the expense of the consumer.

Stef Blok, Minister of Foreign Affairs of the Netherlands paid a visit to Turkey on 3-4 October 2018. During the visit, the Turkish-Dutch bilateral relations, current regional and international issues were on the agenda of the meetings. Foreign Minister Mevlüt Çavuşoğlu and his Dutch counterpart attended the TRT World Forum in Istanbul on 4 October. The Minister and the new Dutch Ambassador to Turkey, Marjanne de Kwaasteniet have visited the Dutch Consulate General in Istanbul.

! After a month he received a trade agreement from Sultan Ahmed, the Sultan who had the Blue Mosque built

! Cornelis Haga ordered a large number of business gifts sent to him from the Netherlands

! This was the beginning of a prosperous relationship between the Netherlands and Turkey that has lasted over 406 years
